The Sacramento County Department of Transportation is moving forward with construction of the Florin Road Bicycle and Pedestrian Improvement Project between Franklin Boulevard and Power Inn Road to improve accessibility, safety, and to resurface the roadway pavement. Construction Activities:

The project was bid on August 22, 2024 and will be at the Board of Supervisors for award to Teichert Construction on September 24, 2024. Construction is scheduled to begin in November 2024 with completion anticipated in September 2025. Some preliminary work may occur prior to the start of construction including construction area signing/fencing, tree trimming, and utility work. Access will be maintained to all residences, businesses, pedestrians, and bicyclists during construction.


Project work includes:

- Widen roadway for bike lanes, bus stops, reconstruct sidewalks, driveways, and landscaped medians.
- Replace and update traffic signal poles and equipment, pedestrian signal heads, and crosswalk push buttons.
- Delineate and install signage for bike lanes from Franklin Boulevard to East Parkway and from 6th Pkwy-55th Street to Power Inn Road.
- Install new street lights from Chandler Drive to Power Inn Road.
- Resurface the roadway from Franklin Boulevard to Power Inn Road.
