The Sacramento County Department of Transportation is moving forward with construction of the Folsom Boulevard Complete Streets Phase I Project on the south side of Folsom Boulevard between Mayhew Road and Bradshaw Road. ### Construction Activities:

The project was bid on November 4, 2021 and awarded to Sierra National Construction, Inc. Construction is scheduled to begin in February 2022 with completion anticipated in October 2022. Some preliminary work may occur prior to the start of construction including tree removal, temporary fencing for tree protection, the relocation of utility poles and overhead transmission lines and construction area signing. Access will be maintained to all residences and businesses during construction. Pedestrian and bicycle access will also be maintained.

### Project work includes:

- Widen the south side of Folsom Boulevard to provide buffered bike lanes and sidewalk, including separated sidewalk with landscaping.
- Improved storm drain facilities.
- Installation of decorative street lights.
- Modification to signals at the intersections of Folsom Boulevard/Mayhew Road, Folsom Boulevard/Butterfield Way, and Folsom Boulevard/Bradshaw Road.
