The Sacramento County Department of Transportation is moving forward with construction of the Auburn Boulevard Bicycle and Pedestrian Improvement Project from west of Annadale Lane to west of Winding Way. Construction Activities:

The project was bid on December 12, 2019 and awarded to McGuire and Hester. Construction is scheduled to begin in April 2020 with completion anticipated in September 2020. Some preliminary work may occur prior to the start of construction including tree removal, temporary fencing for tree protection, and construction area signing. Access will be maintained to all residences and businesses during construction. Pedestrian and bicycle access will also be maintained.

Project work includes:

- Construction of curb/gutter, sidewalks, ramps, bicycle lanes, street lights, and transit bus pullouts.
- Installation of a pedestrian-activated traffic signal west of Annadale Lane.
- Installation of drainage improvements and driveway reconstruction in areas of new sidewalk construction.
- Installation of bicycle lane signage and pavement markings.



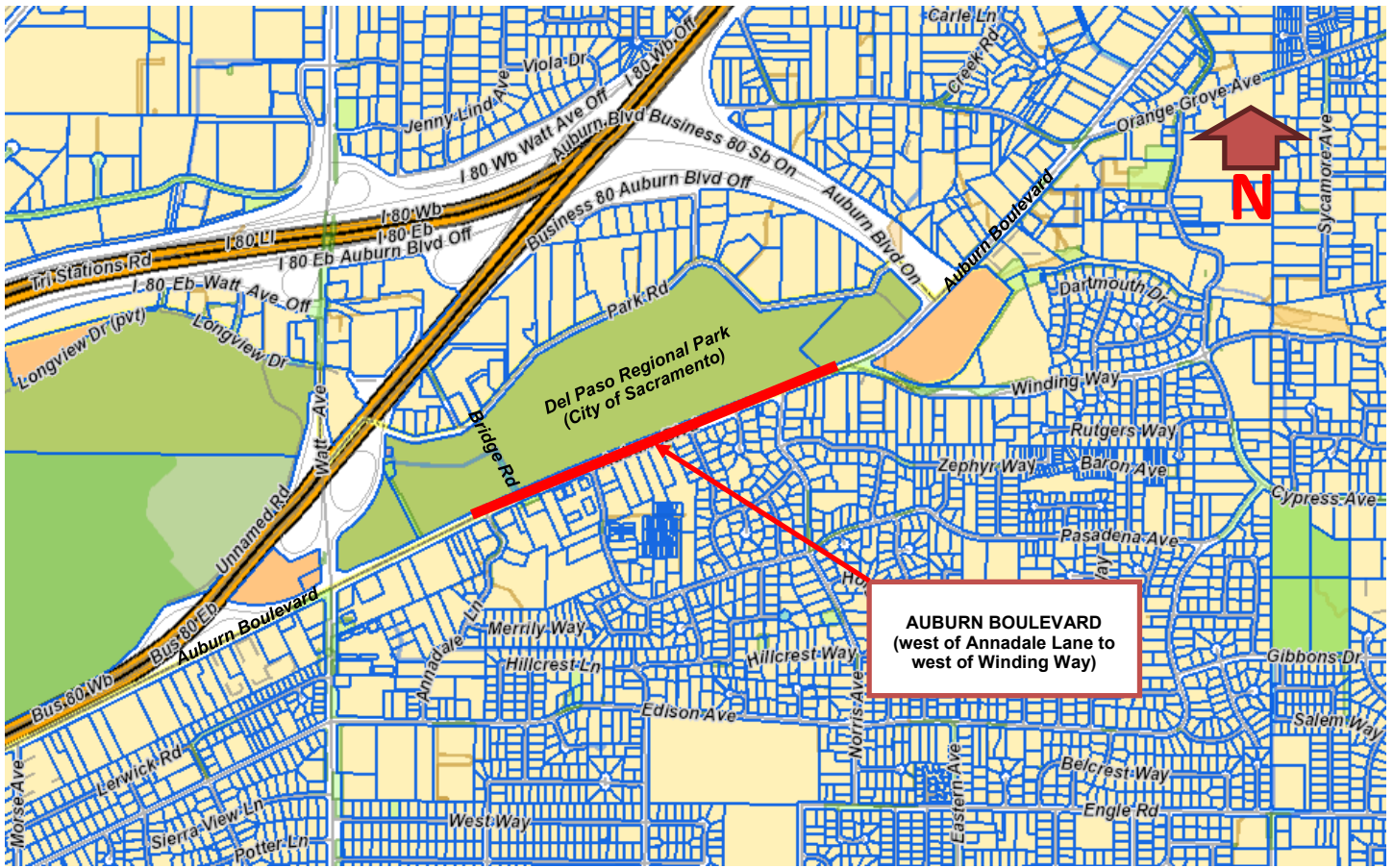
